Motivated & Empowered Inc. empowers at-risk youth and families through education, mentorship, family support, workforce development, housing stability, and community-based services. Our most significant activities include youth mentoring and leadership programs, academic and after-school support, parenting and maternal health services, violence-prevention initiatives, case management, workforce readiness, and assistance connecting families to essential resources.

BloomNourish provided comprehensive maternal and family support services to pregnant and parenting young mothers. The program promoted healthy pregnancies, positive birth outcomes, infant well-being, parenting confidence, and long-term family stability through prenatal and postpartum education, individualized case management, home visits, transportation assistance, support during medical appointments, parenting education, infant-care resources, referrals to healthcare and community services, and emergency assistance. During the year, BloomNourish provided \$3,500 in housing-stability stipends to three young mothers experiencing housing-related financial hardship. These stipends helped participants address immediate housing needs and maintain safer, more stable living environments for themselves and their children. BloomNourish's long-term objective is to reduce barriers to prenatal and postpartum care, strengthen parenting skills, improve maternal and infant health outcomes, and help young families achieve greater stability and self-sufficiency.

The Juvenile Intervention Program provided prevention, intervention, and supportive services to youth who were involved with or at risk of becoming involved with the juvenile justice system. The program addressed behaviors and circumstances that can contribute to court involvement, school disengagement, violence, family instability, and other adverse outcomes. Services included individualized assessments, case management, mentoring, social-emotional development, life-skills education, conflict resolution, accountability planning, family engagement, academic support, community-service opportunities, positive recreational and educational activities, and referrals to behavioral health and other community resources. Program staff worked with youth and their families to identify strengths, establish personal goals, improve decision-making, increase school and community engagement, and reduce the risk of continued justice-system involvement.

The Youth Mentoring Program served 100 youth by connecting participants with caring and trusted adult mentors who provided consistent guidance, encouragement, and positive support. The program was designed to strengthen participants' confidence, decision-making skills, academic engagement, social-emotional development, leadership abilities, and connection to their families and communities. Youth participated in individual and group mentoring activities, educational and life-skills sessions, community-service projects, positive recreational experiences, and conversations addressing personal goals, healthy relationships, conflict resolution, and future planning. The program's long-term goal is to help young people build supportive relationships, avoid high-risk behaviors, improve educational and personal outcomes, and successfully transition into adulthood.
